Definitions

Within the policy the following definitions apply:

authorised officer:	an Officer of the Council authorised by it to act in accordance with the provisions of the Local Government (Miscellaneous Provisions) Act 1992.
Council:	St Albans City and District Council
stall:	any stall, vehicle, cart or barrow used to trade from
street trading:	the selling or exposing or offering for sale of any article (including a living thing) in any street.
street:	includes: a) any road, footway, or other area to which the public have access without a payment b) a service area as defined in Section 329 of the Highways Act 1980 and also include any part of the street.
consent street:	a street in which street trading is prohibited without the consent of the Council
consent:	a consent to trade on a street granted by the Council, pursuant to Paragraph 7, Schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982.
consent holder:	the person or company to whom the consent to trade has been granted by the Council.
Licensing Committee	the committee of councillors sitting at a hearing to determine a reconsideration of the officers' decision to refuse a consent
non-industrial area	any area that is not on an industrial estate
prohibited street	means a street in which street trading is prohibited

Introduction

St Albans City and District Council has resolved to control street trading. This means that you cannot trade in any street in the district unless you have been granted a street trading consent. Street trading is allowed in consent streets but not allowed in prohibited streets. We made this decision on 6th January 2005.

We will use this Policy when considering applications for street trading in the District. We will consider each application on the basis of the information you provide.

Our powers and duties

We can choose to regulate people selling items or services from a stall in our District by adopting the provisions set out in the Local Government (Miscellaneous Provisions) Act 1982, Schedule 4. The law allows us to adopt certain streets as consent streets and prohibited streets. This means we can regulate who is trading and where they are trading.

Apart from the prohibited streets listed in Appendix 2 all streets within the City and District of St Albans are designated consent streets.

Role of street traders

We accept that many people trade from stalls and provide a valuable contribution to the community. There are many different types of street trading. For example, an ice cream van, a stall selling flowers, a cart selling crafts or a burger van.

Local traders provide an important contribution to the local economy and we want to support them and encourage more diverse trading.

The following are **not** street trading:

- A person trading as a pedlar under a pedlar's certificate
- A market stall within St Albans Charter Market
- Trading in a trunk road picnic area
- Trading as a news vendor (Where the only items sold are newspapers or periodicals and the vendor operates without a stall or receptacle or with a stall or receptacle that does not exceed 1metre in length or width or 2 metres in height, occupy a ground area exceeding 0.25 metres sq or stand on the carriageway of a street.)
- Trading outside a petrol station or outside a premises used as a shop as part of that business
- Selling things as a rounds man
- Trading that relates to the Highways Act 1980
- Trading under a Street Collection Permit (obtained from Street Collections at <http://www.stalbans.gov.uk/business/BusinessLicences/OnStreet/charity-collection-licences/>)

Making your application

You can apply for a street trading consent by completing the application form found at Appendix 1 and sending this to us. You must also send the following documents with your application:

- a) a completed and signed application form
- b) one passport sized photograph of you
- c) the full fee
- d) if you want to trade from a fixed position, a copy of a map of at least 1:1250 scale. You should mark your proposed position on the map with a red line
- e) a letter from the landowner giving their permission to trade if it is on private land

- f) one photographs of the stall, van, barrow, cart etc that you intend to use
- g) an original copy of your public liability insurance certificate (£5 million)

Your application should be addressed to Street Trading, Regulatory Services, St Albans City & District Council, St Peter's Street, St Albans, AL1 3JE.

We will normally process a street trading consent within 10 days after the consultation period (28 days), unless objections are received.

Consultation on applications

Before we grant or renew a consent we will consult with certain organisations and individuals called consultees. We consult:

Hertfordshire County Council Highways
Regulatory Services
Planning and or Community Services
Hertfordshire Constabulary
Ward Councillors
Parish or Town Council (if applicable)

If you apply for a consent in a residential area, we may consult the property owners within 100 metres of the proposed site. When we determine your application we will consider any comments made by the consultees.

How we assess the suitability of the site

We will not usually grant a street trading consent where:

- there will be a significant effect on road safety because of the location of the street trading, or the way customers will access the site, or any obstruction of sight lines at pedestrian crossings or road junctions or
- locality of the site, or
- there would be a significant loss of amenity caused by traffic, noise, rubbish, potential for vermin, odour or fumes, or
- there is already adequate provision of a similar trade in the immediate vicinity, or
- there is a conflict with Traffic Orders such as waiting restrictions, or
- the site does not allow for the consent holder, staff and customers to park in a safe manner, or
- the street trading causes any health and safety risk.

Inspection of the street trading stall

We will inspect the vehicle, van, trailer, stall you propose to use for your street trading. We expect the stall to comply with the legal requirements for the type of street trading proposed. This list shows the relevant law you may need to comply with:

- Food Premises (Registration) Regulations 1991
- Food Safety Act 1990
- Food Safety (General Food Hygiene) Regulations 1995 (as amended)
- The Food Safety (Temperature Control) Regulations 1995

- Health and Safety Act at Work etc 1974 and any Regulations under this Act
- Environment Protection Act 1990

How we determine street trading consent applications

We will use the factors set out below to make decisions on street trading consents. Any comments from consultees that relate to these factors will be taken into account. We consider all of these to be of equal importance.

a) Public Safety

The location of the street trading should not present a substantial risk to the public in terms of road safety, obstruction or fire hazard. The term “public” refers to both customers and other members of the public using the street.

b) Public Order

The street trading should not present a risk to good public order in the locality in which it is situated. Comments from the Hertfordshire Constabulary will be particularly relevant when we consider this factor.

c) Avoidance of Nuisance

The street trading should not present a substantial risk of nuisance from noise, rubbish, potential for vermin, smells or fumes of households and businesses in the vicinity of the proposed street trading site. Comments from Council officers shall be taken into consideration.

d) Similar items being sold or services provided

We will consider if a shop or street trading stall selling a similar item or providing a similar service already exists in the immediate locality of the proposed street trading site.

e) Market Days

We will not permit trading in the town centre on market days.

f) Persons under the age of 17 years

We will not grant a street trading consent to persons under the age of 17 years.

g) Trading Hours

We will only grant street trading consents between the hours of 08:00hrs and 23:00hrs

Terms and conditions attached to street trading consents

If we grant you permission for street trading, we will issue a consent with conditions attached. You can find a copy of our standard conditions at Appendix 4. If the consent is granted by the Licensing Committee they may add additional conditions. The consent will be issued within 10 days of the decision.

The consent will include:

- the unique consent reference number
- the name of the consent holder
- the days and hours when street trading is permitted
- the goods that may be sold or services that may be provided
- the location of the consent site

The conditions attached to the consent must be complied with at all times. Any failure to do so could lead to the consent being revoked, or not renewed.

How we issue street trading consents

A consent will be issued for 12 months. The consent will expire 12 months after the date it was issued. You can apply to renew your consent before it expires.

If you pay by cheque that is dishonoured by your bank we will write to notify you. You then have 7 days to provide payment. If you do not provide payment in 7 days we will revoke your consent.

Different types of consents

We issue different types of consents depending on how you want to trade. If you trade from a fixed location you will have a static consent. If you trade around the district you will have a mobile consent. A daily consent may be issued to a current trader for one-off events for example at a classic car show or fete.

If we decide to refuse or revoke

If we refuse your application for grant or renewal of a street trading consent you will be notified in writing within 10 days with the reasons for refusal

If you are not satisfied with the decision you may request in writing within 21 days of the date of the refusal letter a hearing in front of the Licensing Committee for it to reconsider your application.

If we refuse your application we will refund part of the fee less any administrative costs. You can find details of these costs at appendix 3.

Representation to the Licensing Committee

When you request a hearing by the Licensing Committee we will arrange it and advise you in writing of the date, time and place. You should attend the hearing and you can be represented by a solicitor, or supported by a friend or colleague. We will prepare an agenda for the hearing and you will receive a copy of it before the hearing. The agenda will contain the procedure and any officer reports.

We write to let you know the decision of the Licensing Committee within 5 working days of the hearing.

General Information on Street Trading Consents

Reimbursement of Fees

If you cease to trade and surrender your consent we will not normally reimburse any of the fees, unless there are exceptional circumstances

Co-operation with authorised officers and police officers

You should co-operate with authorised officers of the council and police officers at all reasonable times.

Sub-letting or transferring

We grant the consent to you and it is non-transferable and there can be no sub-letting.

Variance of Conditions

We may, at any time, vary the conditions of a street trading consent. If we do we will notify you in writing

Consent on private land

Where your proposed site for trading is on privately owned land you must seek permission from the relevant landowner before we can grant a consent. You should send written permission with your application.

Consents for special events (current traders)

Where you want permission to carry out street trading at an event such as a street fare you must obtain a daily consent and provide permission from the Event Organiser. You do not need permission from the land owner in this case.

Public Liability Insurance

If your insurance is due for renewal during the time covered by your consent, it is your responsibility to provide an original public liability insurance certificate for the length of the consent. We will consider any gaps when you are not covered by insurance as a reason to revoke your consent.

When we take enforcement against street trading

We actively enforce the provisions of the street trading law in a fair and consistent manner. All enforcement activities will comply with our Corporate Enforcement Policy. If you are found to be trading without first obtaining a street trading consent you are committing an offence punishable on conviction by a fine of up to £ 1,000.

We will apply these principles when we enforce the street trading provisions:

Openness: We will be open about how we enforce the law in relation to street trading. We will discuss your failure to comply or any problems we have with you as part of the enforcement process.

Helpfulness: We will advise and assist you to meet the requirements of the law. We will also strive to provide a courteous and efficient service to you.

Proportionality: We will minimise the cost of compliance for businesses and individuals by ensuring that any action we take is proportionate to the risk or wider public benefit.

Consistency: We will carry out our duties in a fair, equitable and consistent manner considering our Enforcement Policy, this policy and any national codes of practice and guidelines.

Other agencies may take enforcement action where you fail to comply with the law they regulate e.g. trading standards.

Local Government (Miscellaneous Provisions) Act 1982 - Part III, Section 4 Control of Street Trading

If you wish to trade in streets within St Albans City and District Council you must obtain a street trading consent from us. If you trade without obtaining a street trading consent you will be committing an offence.

The following are not street trading:

- A person trading as a pedlar under a pedlar's certificate
- A market stall within St Albans Charter Market
- Trading in a trunk road picnic area
- Trading as a news vendor (Where the only items sold are newspapers or periodicals and the vendor operates without a stall or receptacle or with a stall or receptacle that does not exceed 1metre in length or width or 2 metres in height, occupy a ground area exceeding 0.25 metres sq or stand on the carriageway of a street.)
- Trading outside a petrol station or outside a premises used as a shop as part of that business
- Selling things as a rounds man
- Trading that relates to the Highways Act 1980
- Trading under a Street Collection Permit (Charity)

The term "street" includes any road, footway, or other area to which the public have access without payment, and also a service area as defined in Section 329 of the Highways Act 1980. It also normally includes any part of a street and forecourts to which the public have access.

We enclose a street trading consent application form. You should complete the form and return it to us together with the fee and the documents included in the checklist. You should read the Council's street trading policy before completing the application form www.stalbans.gov.uk/business/streettrading/. We will consult with the organisations listed below:

The Council will contact the following:

- Police
- Highways
- Ward Councillors
- Town or Parish Council (if applicable)
- Regulatory Services (health and safety, food safety and noise)
- Planning and or Community Services
- If you apply for a consent in a residential area, we may consult the property owners within 100 metres of the proposed site.

Reimbursement of Fees

If you cease to trade and surrender your consent we will not normally reimburse any of the fees, unless there are exceptional circumstances

Where we refuse an application we will deduct administrative fees as follows:

20% of full fee paid after Licensing Officer's decision [up to a maximum of £400]

50% of full fee paid after Licensing Committee decision [up to a maximum of £800]

The consents available are:

• Static Site (Anywhere in St Albans District except St Peters St and Market Place) 1 year	£750.00 per year
• Mobile Traders 1 year	£500.00 per year
• St Peters Street *fee payable per day of trade for 1 year i.e. Trade every Monday for 1 year = £1000.00 Trade every Monday and Tuesday for 1 year - £2000.00 Consents will not be issued to trade on Wednesday or Saturday as these are market days. Permissions may be temporarily removed when special events take place. No refund will be given for those days where permission has been temporarily removed.	£1000.00*
• Daily Rates for Special Events (current traders only)	£45

Duration of Consents

All consents expire after 12 months apart from daily consents which expire daily.

- (c) That part of the Western Service Road, St Peters Street, St Albans, from a point opposite Waddington Road (adjacent to No. 17 St Peters Street) northwards to a point opposite the alley adjacent to No. 51 St Peters Street (BHS) be designated a consent street

With regards to (c) above as St Albans has a charter market the Market & Fairs Clauses defines a market as 5 stalls so for this reason only 4 consents are allowed in the area mentioned in (c) above on non- market days.

APPENDIX 4

STANDARD CONDITIONS

The following standard conditions will normally be attached to a Street Trading Consent:

- a. You must not sublet your consent.
- b. You must keep any stall, barrow or vehicle used in connection with a consent in good condition.
- c. You will be responsible for the temporary storage of rubbish, liquid and other material accumulated or created whilst trading and its subsequent removal from the site and shall satisfy us regarding its proper disposal.
- d. You will be responsible for collecting and removing all litter within 100 metres in any direction of the stall or vehicle and disposing of it in a proper manner.
- e. No silage water from the washing of food equipment or hand washing shall be allowed to discharge into the ground and the consent holder shall satisfy us regarding its proper disposal.
- f. When you are trading you must make sure that you display a sign bearing:
 - your name and address
 - expiry date of your consentso that it is clearly visible to all customers at the vehicle/stall.
- g. If you intend to sell food from a stationary vehicle/stall you must make sure the vehicle/stall is suitable. You must managed the vehicle/stall so that you comply with the relevant hygiene regulations currently in force within the provisions of the Food Safety Act 1990.
- h. You must not obstruct the street or cause danger to persons using the street.
- i. You must not cause any nuisance or annoyance (whether to persons using the street or otherwise).
- j. If you have consent to trade in the Town Centre you will not be able to use this on market Days.
- k. You must only place advertisements or other notices inside the area shown in your consent to be your trading site, unless you have received written approval from the Local Planning Authority.
- l. You shall not directly or indirectly hawk, tout or solicit custom for or advertise by way of flyer, public address system or otherwise without our written consent.
- m. You must not cause or allow to be caused any damage to the street surface, street furniture, lighting and landscaping within the permitted area. You will be responsible for the making good of any such damage.

- n. You should not place any signage or objects on the highway or area surrounding the vehicle/stall unless agreed by us. We do not permit fly posting within St Albans District Council area.
- o. You must not allow any obstruction to fire hydrants, manholes or other street furniture etc, resulting from your business.
- p. You must not use mobile generators without our written permission. Where we grant permission the generators must be positioned so that they do not present a danger to the public, do not present a fire or similar hazard to the stall, goods displayed thereon or adjoining premises and do not give rise to a nuisance by reasons of noise, vibration, smoke or smell.
- q. You must not store combustible materials in the vicinity of a generator and you must have suitable first aid and fire fighting appliance(s) available.
- r. We would prefer generators to be fuelled by diesel oil.
- s. You must not store any fuel in the vicinity of a generator.
- t. You must not fill up the generators during the trading day. You must fill up your generator at the start of the day.
- u. You shall ensure that any equipment, such as a generator, is in a safe working condition and suitably cordoned off to ensure that the general public do not have access to the equipment.
- v. If you are using any form of power you must have a minimum of a one-litre fire extinguisher suitable for use on the type of equipment.
- w. If you are selling food a valid food registration certificate must be in force for the business
- x. If you are using an electrical generator is used or a connection is made to permanent electricity supply the consent holder must ensure that the electrical installation is safe. If there is any doubt as to the integrity of the supply or installation the council may ask for a safety certificate from a competent person or body. In most circumstances an inspection by an NICEIC or ECA approved electrician will be satisfactory. At no time should electric cables be draped across roadway, public footpaths or any other area where the public have access.
- y. You must not use or permit to be used on the pitch area or within the immediate vicinity any radio, cassette, CD players, iPod or MP3s etc or other equipment or apparatus to produce music or other amplified sound.
- z. You and your assistants must not trade under the influence of any illegal or intoxicating substance. If you or your assistants are found with illegal substances on your pitch we will revoke your consent.
- za. You and your assistants must treat the public fairly and with courtesy at all times.

- zb. We retain the right to alter or temporarily suspend the allocated sale area in the event of unforeseen circumstances or for special 'one off' occasions of national or local significance.

SPECIAL CONDITIONS

When we are dealing with your application we can attach any reasonable and proportionate conditions that we considered necessary to:

- maintain adequate public safety
- avoid nuisance and anti-social behaviour
- generally preserve the amenity of the specific locality.
